IF THIS HAPPENS	DO THIS
Tanker/Vehicle Accident	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. Call the emergency services: Dial 111
Spill or leak	Keep all bystanders away. Chemical resistant protective clothing, goggles, half face-piece respirator with combined dust and vapour cartridge, full length clothing and chemical resistant gloves. Absorb spilled product with non-combustible absorbent and place in a sealable container for disposal. Wash down affected area with water plus detergent. Seek advice from local authority regarding disposal.
Fire	Call the Fire Service: Dial 111. Wear chemical resistant protective clothing and breathing apparatus. Extinguish fires with water fog, foam, dry chemical or carbon dioxide. During a fire toxic fumes may be released. Cool sealed drums with water to prevent rupture due to thermal expansion. Contain run-off. Keep non-involved persons away.

FIRST AID

If Swallowed:	Do NOT induce vomiting. For advice contact the National Poisons Centre 0800 POISON (0800 764 766) or a doctor immediately.
If in Eyes:	Hold eyelids apart and flush the eye continuously with running water for at least 15 minutes. Get medical attention.
If on Skin:	If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. Do not scrub the skin.
If Inhaled:	Remove patient to fresh air. If not breathing, give artificial respiration, preferably mouth-to-nose. Get medical attention if symptoms develop.

STORAGE AND SEGREGATION SUMMARY

Storage: Store in original container in a secure, cool, dry, ventilated place away from direct heat or direct sunlight. Store away from foodstuffs, seeds, fertilisers, and ensure inaccessibility to children and/or animals. Keep container sealed when not in use.
