Tanker/Vehicle	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks.				
Accident	Call the emergency services: Dial 111				
Spill or leak	Wear overalls, chemical resistant gloves, boots and safety goggles. Prevent further spillage. Sweep up solids without generating dust. Wash down affected area with water plus detergent. Absorb and collect washings and place in the same sealable container for disposal. Seek advice from the local authority regarding disposal.				
Fire	Call the Fire Service: Dial 111. Wear chemical resistant protective clothing and breathing apparatus. Extinguish fires with water fog, foam, dry chemical or carbon dioxide. During a fire toxic fumes may be released. Cool sealed drums with water to prevent rupture due to thermal expansion. Contain run-off. Keep non-involved persons away.
