IF THIS HAPPENS	DO THIS
Tanker/Vehicle Accident	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. Call the emergency services: Dial 111
Spill or leak	Wear chemical resistant; coveralls, gloves, boot, respiratory protection and safety goggles. Prevent further spillage. Sweep up product and place in sealable container for disposal. Wash down affected area with water plus detergent. Absorb and collect washings and place in the same sealable container for disposal. Seek advice from the local authority regarding disposal.
Fire	Call the Fire Service: Dial 111. Wear chemical resistant protective clothing and breathing apparatus. Extinguish fires with foam, dry chemical or carbon dioxide. During a fire toxic fumes may be released. Cool sealed drums with water to prevent rupture due to thermal expansion. Contain run-off. Keep non-involved persons away.

FIRST AID

If Swallowed:	DO NOT induce vomiting. For advice contact the National Poisons Centre 0800 POISON (0800 764 766) or a doctor immediately.
If in Eyes:	Hold eyelids apart and flush the eye continuously with running water for at least 15 minutes. Get medical attention.
If on Skin:	If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. Do not scrub the skin.
If Inhaled:	Remove patient to fresh air. If not breathing, give artificial respiration, preferably mouth-to-nose. Get medical attention if symptoms develop.

STORAGE AND SEGREGATION SUMMARY

Storage: Store in a locked, cool, dry, well-ventilated area. Keep out of reach of children. Store in the original, tightly closed container, in a secure place away from feed, seed, fertiliser, foodstuffs and animal and human health products/remedies.

Aggregate Storage Volume Thresholds: When stored with substances of the same hazard classification the aggregate quantity must be considered. For full details refer to the current NZS8409 Management of Agrichemicals and the HSNO Emergency Management Regulations.
