## HANDLING PRECAUTIONS

## STORAGE

Store in original container tightly closed and in a dry, cool area away from foodstuffs. Storage must be generally in accordance with NZS8409 Management of Agrichemicals. See the SDS for further information.

## DISPOSAL

Dispose of this product only by using as per label directions, or at an approved hazardous substance waste receipt facility, or local authority waste transfer station. Triple rinse empty container and add residue to spray tank. Recycle empty container through Agrecovery (0800 247 326, [www.agrecovery.co.nz](http://www.agrecovery.co.nz)). Otherwise submit to a local authority waste transfer station. Do NOT use the container for any other purpose. Avoid contamination of any water supply with chemical or empty container.

## PRODUCT INFORMATION

AddaWett 1000 is a general purpose, non-ionic surfactant designed to improve the coverage of crop protection products. AddaWett 1000 reduces the surface tension of the spray and increases the spread over the surface of the plant to assist in spray coverage. AddaWett 1000 will enhance the coverage and adherence to waxy and hairy hard-to-wet surfaces. AddaWett 1000 aids the coverage and penetration of the sprays into cracks and crevices and will form an even spray on the target plants. AddaWett 1000 also resists light rainfall and reduces the erosion of the chemical from the leaves.

## RECOMMENDATIONS

Follow the crop protection product labels for specific recommendations on non-ionic adjuvants.

**Insecticides, Fungicides and Plant Growth Regulators:** Use 25 ml/100 litres of water. On hard to wet surfaces, e.g. grape bunches, forage brassicas, cabbages, onions etc., increase the rate to 50-75 ml/100 litres water.

**For vineyard grapes:** Use with sulphur, other fungicides and insecticides at 75 ml/100 litres.

**Herbicides:** Use 25-50 ml/100 litres and follow the herbicide label recommendations. Do not use with selective herbicides unless a non-ionic surfactant is recommended.

**Use with sulphur:** When used with sulphur products, refer to the sulphur label for temperature use restrictions.

## WARNING

DO NOT USE ON SENSITIVE FRUIT CROPS, TABLE GRAPES OR ORNAMENTAL CROPS INCLUDING THOSE GROWN FOR CUT FLOWERS, FOLIAGE AND NURSERY PLANTS.

Use an alternative adjuvant with a proven history of crop safety. AddaWett 1000 may induce increased levels of russet in apples, pears and other russet prone crops.

## COMPATIBILITY

AddaWett 1000 is compatible with most commonly used insecticides, fungicides, herbicides and foliar fertilisers.

## FIRST AID
