Tanker/Vehicle	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks.

Wash down affected area with water plus detergent. Absorb and collect washings and place in the same sealable container for disposal. Seek advice from the local authority regarding disposal.						
Fire	<b>Call the Fire Service: Dial 111.</b> Wear chemical resistant protective clothing and breathing apparatus. Extinguish fires with water fog, foam, dry chemical or carbon dioxide.
