Keep people away, warn other traffic. Check for spills, leaks. Accident Call the emergency services: Dial 111 Spill or leak Wear, chemical resistant coveralls gloves, boots respiratory protection (Organic Vapour standard minimum) and safety goggles. Prevent further spillage. Contain and control leakage/spillage. Use non-organic absorbent material such as clays or sand to clean-up spilt material. Wash down affected area with water plus detergent. Absorb and collect washings and place in the same sealable container for disposal. Seek advice from the local authority regarding disposal. Fire Call the Fire Service: Dial 111. Wear chemical resistant protective clothing and breathing apparatus. Extinguish fires with water fog, foam, dry chemical or carbon dioxide. During a fire toxic fumes may be released. Cool sealed drums with water to prevent rupture due to thermal expansion. Contain run-off. Keep non-involved persons away. **FIRST AID** If Swallowed: Do NOT induce vomiting. For advice contact the National Poisons Centre 0800 POISON (0800 764 766) or a doctor immediately. Hold eyelids apart and flush the eye continuously with running water for at least 15 minutes.
