Wear chemical resistant protective clothing and breathing apparatus. Extinguish fires with water fog, foam, dry chemical or carbon dioxide. During a fire toxic fumes may be released. Cool sealed drums with water to prevent rupture due to thermal expansion. Contain run-off. Keep non-involved persons away. **FIRST AID** If Swallowed: Do NOT induce vomiting. If in Eyes: Hold eyelids apart and flush the eye continuously with running water for at least 15 minutes. Get medical attention.
