Prevent further spillage. Contain and control leakage/spillage. Sweep up or if liquids use absorbent material to clean-up spilt material. Wash down affected area with water plus detergent. Absorb and collect washings and place in the same sealable container for disposal. Seek advice from the local authority regarding disposal. Fire Call the Fire Service: Dial 111. Wear chemical resistant protective clothing and breathing apparatus. Extinguish fires with water fog, foam, dry chemical or carbon dioxide. During a fire toxic fumes may be released. Cool sealed drums with water to prevent rupture due to thermal expansion. Contain run-off. Keep non-involved persons away. **FIRST AID** If Swallowed: Do NOT induce vomiting.
