HANDLING PRECAUTIONS

STORAGE

Store in original container tightly closed and in a dry, cool area away from animal and human foodstuffs, remedies, fertilisers and seeds. Stores containing 1000 litres require secondary containment and signage and more than 100 litres require emergency response plans.

PERSONAL PROTECTION

Avoid skin and eye contact and inhalation of spray mist. When using wear protective clothing such as goggles or face shield, impervious gloves, coveralls and boots. Remove protective clothing and wash hands and face thoroughly before meals and after work.

EQUIPMENT

Apply using well maintained and accurately calibrated equipment.

DISPOSAL

Triple rinse empty container and add rinsate to the spray tank. Dispose of product only by using according to the label. Recycle empty container through the Agrecovery programme (0800 247 326, www.agrecovery.co.nz). Otherwise, crush and bury in a suitable landfill. DO NOT reuse this container for any other purpose.

FIRST AID

Spillage:

DIRECTION FOR USE

Koil Spray Adjuvant can be mixed with with various selective and non-selective herbicides and pesticides whenever the addition of an adjuvant oil is recommended on the herbicide/pesticide label. The recommended use rate for Koil Spray Adjuvant is 500mls/100L of spray mix.

Mixing:

- These are general mixing instructions. Always follow mixing instructions of each ingredient in tank-mix. Ensure product compatibility. Recommendations on other product labels take precedence over mixing instructions on this label.
- If tank mixing, use the following general order for mix partners after half filling the spray tank with water. First add water dispersible granules; second add flowable formulations; third add emulsifiable concentrates; fourth add water soluble liquids then add Koil Spray Adjuvant.
- Continue filling the tank to the required volume maintaining agitation at all times.

CLEANING SPRAY EQUIPMENT

To rinse and decontaminate spray equipment refer to the relevant product labels for instructions.

WITHHOLDING PERIOD

Observe withholding periods specified on the relevant herbicide/ pesticide labels.
