Tanker/Vehicle	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks.

Spill or leak	Wear chemical resistant: coveralls, gloves, boots, respiratory protection and safety goggles. Prevent further spillage. Absorb spilled product and place in sealable container for disposal. Wash down affected area with water plus detergent. Absorb and collect washings and place in the same sealable container for disposal. Seek advice from the local authority regarding disposal.							
Fire	Call the Fire Service: Dial 111. Wear PVC protective clothing and breathing apparatus. Extinguish fires with water for foam, dry chemical or carbon dioxide. During a fire toxic fumes may be released. Cool sealed drums with water to prever rupture due to thermal expansion. Contain run-off. Keep non-involved persons away.
