| <b>Tanker/Vehicle Accident</b> | Switch off engine and electrical equipment. Keep people away. Warn other traffic. Check for spills and leaks.<br><b>Call the emergency services: Dial 111</b>   |
| <b>Spill or leak</b>           | Wear, chemical resistant coveralls, boots and gloves (barrier multilayer, nitrile or neoprene), respiratory protection (to a minimum of Organic Vapour specification) and eye protection. Prevent further spillage or leakage. Absorb spilled product inert and inorganic absorbent materials and place in a sealable container. Wash affected area with water detergent solution. Absorb washings and place in sealed container. Dispose of to a suitable landfill or other suitable facility. |
| <b>Fire</b>                    | <b>Call the Fire Service: Dial 111.</b> Wear protective clothing including self-contained breathing apparatus. Toxic fumes may be released. Keep people away. Extinguish fires with foam, dry chemical, carbon dioxide or fine water spray. Cool other containers to prevent rupture. Contain run-off.  |

### STORAGE AND SEGREGATION SUMMARY

**Storage:** Keep out of reach of children. Store in the original, tightly closed container, in a secure place away from human and animal feeds and remedies, seed, fertilisers, fungicides, insecticides or foodstuffs and foodstuff packaging.

**Aggregate Storage Volume Thresholds:** When stored with other hazardous substances, the aggregate quantity must be considered. For full details, refer to the current NZS8409 Management of Agrichemicals and the HSNO Regulations.
