Keep people away, warn other traffic. Check for spills, leaks. Accident Call the emergency services: Dial 111 Spill or leak Wear, chemical resistant: coveralls gloves, boots, respiratory protection (Organic Vapour standard minimum) and safety goggles. Prevent further spillage. Contain and control leakage/spillage. Moisten to prevent dusting (if possible) and sweep up and shovel or collect recoverable product and place into sealable recovery drums. Wash down affected area with water plus detergent. Absorb and collect washings and place in the same sealable container for disposal. Seek advice from the local authorities regarding disposal. Call the Fire Service: Dial 111. Wear chemical resistant protective clothing and breathing apparatus. Extinguish fires with Fire water fog, foam, dry chemical or carbon dioxide. During a fire toxic fumes may be released. Cool sealed drums with water to prevent rupture due to thermal expansion. Contain run-off.
