IF THIS HAPPENS	DO THIS
<b>Tanker/Vehicle Accident</b>	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. <b>Call the Emergency Services: Dial 111.</b>
<b>Spill or leak</b>	Wear chemical resistant coveralls, gloves, goggles and respiratory protection with Organic Vapour filters as minimum specification. Prevent further spillage. Sweep up spilled product and place in sealable container for disposal. Avoid raising dust. Wash down affected area with water plus detergent. Absorb and collect washings and place in the same sealable container for disposal. Seek advice from the local authority regarding disposal.
<b>Fire</b>	<b>Call the Fire Service: Dial 111.</b> Wear protective clothing and breathing apparatus. Extinguish fires with water fog, foam, dry powder or carbon dioxide. During a fire toxic fumes may be released. Contain run-off. Keep non-involved persons away.

### FIRST AID

<b>If Swallowed:</b>	Do NOT induce vomiting. Rinse mouth. <b>For advice contact the National Poisons Centre 0800 POISONS (0800 764 766) or a doctor.</b> Rinse mouth.
<b>If in Eyes:</b>	Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing.
<b>If on Skin:</b>	Remove contaminated clothing and wash skin with plenty of soap and water. Do NOT scrub the skin.
<b>If Inhaled:</b>	Remove to fresh air and keep at rest in a position comfortable for breathing. Get medical advice/attention if you feel unwell.
