<b>IF THIS HAPPENS</b>		<b>DO THIS</b>					
<b>Tanker/Vehicle Accident</b>		Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills and leaks. <b>Call the emergency services: Dial 111</b>					
<b>Spill or leak</b>		Do NOT touch or walk through spilled material. Wear <b>Chemical Resistant: Coveralls</b> , gloves, respiratory protection (Organic Vapor minimum specification) facemask or goggles and impervious footwear. Stop leak when safe to do so. Prevent entry into waterways, drains, or confined areas. Absorb spilled product with clays or soil and place in sealable container for disposal. Wash down affected area with water plus detergent. Absorb and collect washings and place in the same sealable, labelled container for disposal. Seek advice from the local authority regarding disposal.					
<b>Fire</b>		Call the Fire Service: Dial 111. Wear chemical resistant protective clothing and breathing apparatus. Extinguish fires with water fog, foam, dry chemical or carbon dioxide. During a fire, toxic fumes may be released. Cool sealed drums with water to prevent rupture due to thermal expansion. Contain run-off. Keep non-involved persons away. During a fire, combustion products are toxic and or irritant. DO NOT use direct jet of water.					
<b>FIRST AID</b>							
<b>If Swallowed:</b>		Rush the patient to the Accident and Emergency Department of the nearest hospital after alerting them by telephone of the estimated arrival time so that treatment is not delayed. Do NOT induce vomiting. Do NOT delay the start of treatment. Take off all contaminated clothing immediately. Begin artificial respiration if the patient is not breathing. Use the mouth to nose rather than mouth to mouth technique. For advice, contact the National Poisons Centre on 0800 POISON (0800 764 766) or an emergency trauma doctor immediately.					
<b>If in Eyes:</b>		Immediately irrigate with copious quantities of water for at least 20 minutes. Eyelids to be held open. Urgently seek medical assistance. Arrange transport to nearest hospital or medical emergency center.					
<b>If on Skin:</b>		Immediately take off all contaminated clothing. Thoroughly wash skin immediately with copious amounts of water followed by soap and water. If swelling, redness, blistering or irritation occurs, seek immediate medical attention. Contaminated clothing should be disposed of or thoroughly laundered before reuse.					
<b>If Inhaled:</b>		Remove victim from exposure. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Begin artificial respiration if the patient is not breathing. Use the mouth to nose rather than mouth to mouth technique. Obtain immediate medical attention.					
<b>STORAGE AND SEGREGATION SUMMARY</b>							
<b>Storage:</b> Keep out of reach of children. Store in locked, secure facility in the original container in a secure, cool, dry, ventilated place away from direct heat or direct sunlight. Store away from foodstuffs, medicines, remedies, seeds, fertilisers, and ensure uncontrolled access to people and/or animals. Keep container sealed when not in use.
